1. GENERAL PROVISIONS.

1.1. Goals and objectives of the competition:

identifying the strongest athletes in Kyokushin;

- increasing the level of sports mastery of the athletes involved in Kyokushin;
- acquisition of competitive experience by athletes;
- promoting the development of mass Kyokushin;
- development and popularization of Kyokushin in Russia.

2. VENUE AND DATES.

2.1. Venue: Saint-Petersburg, 10 Vyazovaya str.,

Universal sports complex "Platonov

volleyball academy"

2.2. Dates: April 25-28, 2025

3. HOSTS OF THE COMPETITION.

3.1. The all-Russian physical culture and sports public organization «Kyokushin Federation of Russia» (further – FKR) performs general management of competition's preparation and holding.

The direct holding of the competition attaches to the International Union "Kyokushin Profi" and to the chief panel of judges.

- 3.4. The hosts of the competition are not responsible for possible injuries received during the competition.
- 3.5. Competitions are held at sports facilities included in the All-Russian Register of Sports Facilities, in accordance with paragraph 5 of Article 37.1. of Federal Law No. 329-FZ of December 4, 2007 "On Physical Culture and Sports in the Russian Federation". The safety of participants and spectators is ensured in accordance with the requirements of the Rules for Ensuring Safety during

Official Sports Competitions, approved by Decree of the Government of the Russian Federation No. 353 of April 18, 2014.

- 3.6. Participation in the competition shall be performed only if the Accident, Life and Health Insurance Contract for the days of the tournament (the insurance must be sports, or with an indication of the "kyokushin" type of sport) is provided to the Admission Commission for each participant.
- 3.7. The organizers provide the participants of the sports event with the medical personnel, as well as with the emergency medical service team on standby.

4. REQUIRENMENTS FOR PARTICIPANTS OF THE COMPETITION AND CONDITIONS FOR THEIR ADMISSION.

- 4.1. Athletes from Russia and other countries in the following age groups are allowed to participate in the sports competition:
- teenage boys and girls (12-13 years old) athletes of 2012-2013 years of birth;
- teenage boys and girls (14-15 years old) athletes of 2010-2011 years of birth;
- junior men and women (16-17 years old) athletes of 2009-2007 years of birth;
- men and women (18 years old and older) athletes of 2007 year of birth and older.

In the age group "junior men and women (16-17 years old)", athletes born in 2007 are admitted if they have not reached 18 years old before the start of the sports competition, i.e. before April 25, 2025.

In the age group "men and women", athletes born in 2007 are admitted if they have reached 18 years old before the start of the sports competition, i.e. before April 25, 2025.

- 4.2. Athletes with the following style qualification restrictions are allowed to participate in the sports competition:
 - teenage boys and girls (12-13 years old) no lower than 7 kyu;
 - teenage boys and girls (14-15 years old) no lower than 6 kyu;
 - junior men and women (16-17 years old) no lower than 6 kyu;
 - men and women (18 years old and older) no lower than 4 kyu.
- 4.3. At the Admission Commission, the representative of the team shall provide the original application (Supplement No. 1), and each participant must have the following documents:
- Identity Document (up to 14 years old Birth Certificate, Certificate from the School with a photo and a seal on the photo (or other document with a photo), 14 years old and older Passport of the citizen of the Russian Federation);
- Document confirming the athlete's style qualification;
- Original of the Insurance Policy of Compulsory Medical Insurance;

- Original of the Accident, Life and Health Insurance Contract for the days of the tournament (the insurance must be sports, or with an indication of the "kyokushin" type of sport);
- For minor athletes the consent of the athlete's parents that their child can practice Kyokushin and take part in the competition (Supplement No. 2A);
- For adult athletes a handwritten application addressed to the Chief Judge on voluntary participation in the competition (Supplement No. 2B).
- 4.4. Each competitor must submit personal protective equipment in accordance with the rules of the sport "Kyokushin" for the Admission Commission (Supplement No. 3).

ATTENTION! If any of the above points is violated, the athlete will not be admitted to the competition.

5. COMPETITION PROGRAM.

- 5.1. The Sports competition is held according to the rules of the Kyokushin World Union (KWU), in accordance with the rules of the sport "Kyokushin", approved by the order of the Ministry of Sports of Russia dated October 21, 2022 No. 847.
- 5.2. The competition is held in the following sports disciplines:

<u>ATTENTION!</u> If an athlete, based on the results of weighing at the Admission Commission, does not enter the declared weight category, the athlete will not be allowed to participate!

5.3. Competition schedule:

April 25, 2025 – teams' arrival date

Admission Commission: from 10:00 to 16:00 from 16:30 to 18:30

April 26-27, 2025 — days of competition
09:00 — start of the competition
18:00 — end of the competition
April 28, 2025 — teams' departure date

A more detailed daily schedule will be published after applications have been processed.

5.4. Timing of kumite fights

Teenage boys and girls 12-13 years old: 2 min + 1 min + weighing + 1 min Teenage boys and girls 14-15 years old: 2 min + 2 min + weighing + 1 min Junior men and women 16-17 years old: 2 min + 2 min + weighing + 2 min

To win by the results of weighing the difference in weight must be 2.5 kg or more. The athlete's weight is determined by weighing on the scales.

5.5. "Kata" and "kata-group" competition program

The sports competition in kata will be held according to the Olympic system, when the judges determine the winner in a pair by raising the flag of the color of the athlete who received the highest score in the pair.

In each round, the athlete must perform a Kata corresponding to the round and age category according to the table:

The sports competition in the sports discipline "kata" is held among teenage boys and girls, junior men and women, men and women separately.

In the competition in the "kata-group" discipline, the composition of the team (3 people)

can be either male and female, or mixed.

6. SUMMING-UP CONDITIONS.

- 6.1. In the sports competition in kumite and kata for teenage boys and girls, junior men and women, winners and prize-winners are determined according to the Olympic system with elimination after one defeat. In the "kumite" and "kata" disciplines defeated semi-finalists will not fight for the 3rd place (two 3rd places). In the "kata-group" discipline defeated semi-finalists shall fight for the 3rd place.
- 6.2. The sports competition in kata for men and women the winner and prize-winners are determined according to the Olympic system, with elimination after one defeat. In all sports disciplines in men and women age group defeated semi-finalists shall fight for the 3rd place.
- 6.3. In case that there are only 3 athletes (groups) in one weight group, they have a round fights (everyone with everyone). The winner of such category is determined according to the bigger number of wins. If every athlete (group) has one-win, additional athletes' points are taken in notes. If each athlete (team) has won one victory, then additional indicators of these participants are taken into account:
 - in the weight categories (in further order):
 - 1) the number of clear victories (Ippon scores);
 - 2) the number of assessed technical actions (Waza-ari scores);
 - 3) the number of official comments and penalty points;
 - 4) the results of weighing the participants (the lighter participant takes a higher place);
 - in the kata and kata-group
 - 1) counting the number of flags cast for and against an athlete (group);
 - 2) if two participants (groups) have the same number of flags, then the result of the personal meeting is taken into account;
 - 3) if all three participants (teams) have the same number of flags, then an additional round of fights is held.

7. AWARDING OF WINNERS AND PRIZE-WINNERS.

7.1. The winners and prize-winners of the competitions are awarded with cups (1st place), medals and diplomas (1-3 places) of the corresponding degrees.

8. TERMS OF FINANCING.

- 8.1. Financing of the cost items related to organizational expenses for preparation and holding of the competition is provided at the expense of the International Union "Kyokushin Profi" and of the participant fees.
- 8.2. Financing of the cost items related to the expenses for full travel of participants of the

competition, coaches and judges (travel to the competition venue and back, meals, accommodation, insurance, participation fee) is provided at the expense of the sending organizations.

8.3. Participation fee

Participation fee is 4500 RUB.

Participation fee for the whole team must be paid at the Admission Commission.

8.4. Amount of the deposit for filing an official protest

According to Article 8 of the Kyokushin Sport Rules, an official representative of the team may file an official protest in the event of a controversial situation on the tatami. According to paragraph 8.1.6 of the Rules, the person filing the complaint is required to deposit a Protest Deposit. The amount of the Protest Deposit is 10,000 (ten thousand) rubles.

9. APPLICATIONS FOR PARTICIPATION.

- 9.1 Preliminary applications for participation in the sports competition are accepted until February 25, 2025 inclusively by e-mail: tournament.pro@mail.ru. Late or incorrectly submitted applications will not be accepted.
- 9.2. At the Admission Commission, the representative of the team shall provide the original application (Supplement No. 1). The application shall be:
 - 1) Signed and stamped by the representative kyokushin organization
 - 2) Provided with the medical conclusion and admission that this athlete can participate in kyokushin tournaments.

ATTENTION TO THE TEAM REPRESENTATIVES!

The sending organization bears full responsibility for the life and health of the athletes registered for the competition. The team representative bears personal responsibility. We recommend that you do not leave children unattended during your entire stay in the city of St. Petersburg and during the journey (both ways).
